



## WEBSITE TERMS OF USE

### INTRODUCTION

Thank you for visiting, [www.EDIFYSCREENING.COM](http://www.EDIFYSCREENING.COM) (the "Site"), which is owned and operated by EDIFY Administration Professionals, Inc. (d.b.a. EDIFY Background Screening) and for the purposes of this agreement referred to as EDIFY. This Web Site Use Agreement ("**Agreement**") is entered into by you and EDIFY.
